TERMS AND CONDITIONS FOR PARTICIPATION AT THE 2023 LAKESHORE BUSINESS LEADERS' SUMMIT

The Malawi Confederation of Chambers of Commerce and Industry (MCCCI) has organised the 2024 Lakeshore Business Leaders' Summit. The objectives of the Summit include brainstorming on solutions to resolve challenges facing the industry; providing a platform for collective lobbying and advocacy by inviting and engaging policy makers; providing a platform for information dissemination where findings for the Malawi Business Climate Survey and other key surveys conducted by MCCCI would be disseminated, and providing networking amongst industry players. This is an annual event that is expected to attract members of the Private Sector and different stakeholders as participants. Participants are therefore required to understand and comply with the Terms and Conditions for participation as contained hereunder.

1. APPLICATION FOR PARTICIPATION

- a. All applications for reservation at the Lakeshore Business Leaders' Summit shall be made on the prescribed Registration Form issued by MCCCI.
- b. The completed application form shall be submitted together with full payment to MCCCI to qualify for allocation of space not later than 1st April 2024.
